# Town Employees Doing Repair Work

Effective Monday, December 18, 1961, and for a temporary period of two and one-half months, Frank Flores, Super-intendent of Cemetery, and Joseph Crowley have been assigned to perform general maintenance work at all Town buildings and properties and are working under the director of the Town Manager at Town Hall, Cape End Manor, Library, and Recreation Department building, according to information released yesterday by Town Manager Walter E. Lawrence.

These two men are also assigned to the Highway Department during snow storms for emergency snow removal work with Mr. Flores in charge of snow removal in the area west of Town Hall.

Mr. Flores continues his work at the Cemetery with Mr. Crowley when needed for funerals or other cemetery work.

Because of frozen ground and limited work at the Cemetery during the winter months, this arrangement has been made by the Town Manager.

Mr. Flores is a former contractor and Mr. Crowley is a former carpenter and as a result, they are making real savings for the Town, far in excess of the salaries paid to them, Mr. Lawrence pointed out. At Town Hall they are repairing defective seats at the Auditorium as directed by the Insurance Company. They have recently completed laying of rubber tile at Caucus Hall and entryway with Town-owned rubber tile in storage at a Town building for over four years. Estimated contract cost would have been \$900.

They will repair the front stairway to Town Hall as directed by the State Department of Public Safety within the appropriation and save approximately \$1000 for the Town.

They will also complete a number of assignments including cleaning, painting, masonry, and carpentry at great savings to the Town that otherwise would require appropriation at the Annual Town Meeting in March.

The arrangement is an excelleint one and enables the Town to do long neglected but necessary maintenance work in our several Town buildings, Mr. Lawrence concluded.



#### NOTICE OF PUBLIC HEARING



The county officers to be chosen this fall are a sheriff, one county commissioner, and two special commisioners. Sheriff Luther Fisk has served two terms and is supposed to be a candidate for re-election. Mr. Isaiah C. Young was elected last fall to fill an unexpired term as County Commissioner and will doubtless be re-elected for a full term without opposition.

The terms of Freeman Howes of Yarmouth, and Jas. H. Hopkins of Provincetown, special commissioners, also close this year. Senator David Fisk has served one term as State Senator and is a candidate for re-election. It is rumored that the friends of Mr. Thacher T. Hallet of Yarmouth will support him for Sheriff and that the friends of Hon. James E. Gifford of Falmouth will try to send him to the State Senate if he can be induced to accept a nomination at this time. The Advocate believes that Nantucket is entitled in all fairness to name the next Senator, and hopes that the republicans of the County will be willing to allow a Senator to Nantucket in 1890. Three Commissioners of Insolvency are also to be chosen this fall, the names of the present incumbents being Nathaniel Sears of Barnstable, F. C. Swift of Yarmouth, and J. H. Hopkins of Province-10wn. - Provincetown Advocate.
