2-1/2-story, 3-bay sidehall dwelling; gable-front roof is sheathed in asphalt shingles; full-width shed dormer on side roof slope; exterior is clad in wood shingles with wood corner boards and trim; flared wall between 1st and 2nd stories; fenestration includes single and paired DHS with wood surrounds; exterior decks on 1st, 2nd, and 3rd stories of left side façade; entrance on front façade is accessed by a panel door; front yard is enclosed by a wood picket fence.
