8 Central Street is a 1 1/2-story, 5-bay center entry cottage. The building is clad in aluminum on the front, with wood shingle on the secondary facades. A stuccoed brick chimney is located at the roof ridge. The main entry consists of a panel door with storm; simple surround with wrapped pilasters and entablature, and 4-light transom. Fenestration includes 6/6 DHS windows with storms and operable shutters. Shutters flank the door, as well.
