24 Winthrop Street is a 2-story, 3-bay dwelling with side-gable roof; central brick chimney. Large shed wall dormer creates 2nd story. Enclosed gable vestibule with pane-and-panel door, storm, and partial cornice returns. Brick stoop with iron railings. Windows include 6/1 false divided replacement DHS, Chicago-style picture window with 4/1 DHS, 1/1 DHS on 1st story; 3/1 wood DHS window at basement level. 2nd-story deck and shed dormer on rear façade.
