3 Carver Court is a 1 1/2-story, 6-bay building with an addition. The side gable roof is clad in asphalt shingles; partial returns; eaves boxed in vinyl; interior brick chimney at roof ridge. The primary entrance is located on the east facade of an enclosed porch and contains wood panel door, window screen and historic 4-pane transom. The enclosed porch has a hipped roof; 24-pane wood picture window and 1/1 vinyl window. Other fenestration includes 1/1 vinyl DHS; 3/3 wood DHS in basement. A 1-story hipped roof addition is located on the west facade; concrete block basement; interior brick chimney with arched cap.
