The outbuilding at 402 Commercial St. is a 2-story, 2-bay garage with residence incorporated into the 2nd story; side-gable roof is sheathed in asphalt shingles; exterior is clad in wood shingles on the 2nd story with concrete block walls on the first story; building sits on a concrete block foundation; fenestration includes 3/3 DHS and casement windows, operable shutters; entry on 1st story is accessed by a multi-pane door; 2nd-story deck is supported by large knee braces and has a crossed diagonal board balustrade.
