### ARCHITECTURAL DESCRIPTION

42 Pearl Street is a 1 1/2-story, 3-bay bungalow. Side gable roof has stuccoed chimney at roof ridge; shed dormer in front roof slope (looks recent). Shed dormer on rear roof slope. Gable roof porch across front facade with battered square posts on battered rusticated block piers. Concrete steps. Central entry with Arts and Crafts inspired pane and panel door with storm and simple surround. Windows are paired 6/1 DHS in front; paired and single 6/1 DHS elsewhere.
