### ARCHITECTURAL DESCRIPTION

429-435 Commercial St. is a 2-1/2-story, 2-bay commercial building; gable-front roof is sheathed in asphalt shingles, wood box cornice with partial returns, shed dormers on side roof slopes; exterior is clad in clapboard siding on the front façade with wood shingles and vertical plank siding on the secondary façades; building sits on an obscured foundation; fenestration includes single-pane wood casements, plate glass display window with vinyl frame; primary entrance is accessed by a modern steel pane-and-panel door; 2nd-story corner boards; wood 1st-story cornice with small brackets; 2nd-floor balcony on side façade supported by brackets; side-gable enclosed entrance vestibule on side façade.
