A PUBLIC APPEAL TO THE COMMUNITY OF PROVINCETOWN

We appeal primarily to all Guest Houses, Motels and Hotels, and Nightclubs, though our concerns affect the entire Community. We ask for the support of everyone.

A volatile situation exists once again in the heavily congested area between 100-200 Commercial Street, late nights throughout the Summer Season.

This danger is to each of us as well as our visitors. The likely prospect of an emergency situation arising during the hours of the late night congestion in this area has unfortunately become a nightmarish reality during the Memorial Weekend. Although no loss of life occurred, the inevitability existed. Our Fire and Rescue vehicles were delayed in their efforts to protect our lives and our homes.

We need to reach our visitors and guide them with alternate means of crowd control in this area. We once again this year appeal to the masses to make use of the Public area at our Town Hall to insure that late night congestion be evenly dispersed.

We have the pledge of the Chief of Police and his department that, with additional patrol in the area of TOWN HALL, the safety of all our visitors and citizens will be protected.
