Dear Chief Meads,

We, the undersigned residents of Provincetown hereby express our shock and outrage at the recent rash of harassment and physical attacks upon members of our community. We request that the Provincetown Police Dept. take the following immediate steps to bring a halt to these incidents before they occur:

1. Institute plain clothes patrols every night using all resources at your disposal.
2. Re-deploy available officers for more effective deterrence and enforcement.
3. Utilize protective custody to remove drunken and unruly individuals from our streets.
4. Begin an immediate education program for your staff, particularly the summer officers, to appraise them of the seriousness of harassment incidents (since these are the precursor to attacks.)
5. Institute a change of attitude in your department, a "get tough" approach, so that the offenders know that harassment and attack of anyone is abhorred by every police officer and will neither be tolerated nor ignored.

We are committed to notifying the Provincetown Police of any incidents of harassment, to appearing in court as witnesses and prosecuting any assailants to the fullest extent of the law.
