Hello Everyone - Pending a successful outcome on September 11th, in order to get the project up and running as quickly as possible - ever mindful that all due care and consideration be given to the planning process - we discussed outlining the specific tasks needed to accomplish this goal. The attached brief outline provides specific areas to focus your efforts on. Your suggestions on who in the community would be a good candidate to help on one or more of the tasks is most welcome. By this time next week I'd like to see people assigned to key tasks so that we can all be working in concert before the curtain rises on the actual project itself. (NOTE: I intend to ask Laurel Guadazno and Richard Caouette to help in one of these tasks next week - others?)

Progress to date on the move-in logistics:

New England Deaconess would like to coordinate our efforts to change locks on building. I am working with Tony Lemme and locksmith to make this happen as soon as possible. Truck reserved through DPW on Thursday 9/13 to move material from Grace Gouveia attic to Freeman Street building through use of Sheriff department community workers. Doug, Alison, Susan and Polly available to oversee move. Folding tables and chairs to be obtained from Town Hall.

Progress to date on prioritization of material:

I spoke with Josephine Del Deo today who shared her thoughts on initial preservation efforts - quite enlightening - and she said to contact her once the material is in the Freeman Street building and she will actively participate in helping to coordinate prioritization. (NOTE: Josephine will likely take a leadership role on this, but will need help).

Progress on technology:

Lyn and I met with MIS Director Beau Jackett and have begun to make progress on determining what systems and equipment will work for the project, with Beau and Lyn conducting further research.

Progress on public relations: Bill is ready to promote the Selectmen's approval of the proposal and the creation of a special gift fund.

Many tasks will be moving forward simultaneously in the next few weeks. While we are determining the technology needs and ordering and setting up equipment, a group can begin to prioritize the collection and developing a road map that we will be following throughout the project. Work flow and procedures can be developed once the software we are using is determined, including how people will access the material - what they do with it when - where do they put it when they're done, who checks for accuracy, quality of work, etc.

It certainly will be an exciting time and if you do not feel capable of contributing on any of the tasks but know of someone who may be - GREAT.

What began as a working group of Town Hall staff in June to meet over access to specific items currently stored in the Grace Gouveia attic has developed into the History Preservation Project and has grown to include Town Board and community members focused on how best to access and preserve important Town historical information.

The attached proposal is the outcome of weekly meetings throughout the summer of the History Preservation Project working group and represents a plan to provide greater ease of access to important historical information, facilitating research and preservation efforts.

This is an ambitious undertaking, but with the Selectmen's approval and support from the community, we have the opportunity to create an invaluable resource accessible to all.

#### **History Preservation Project**

#### **Mission Statement**

To preserve, protect and provide greater access to documents concerning the history of Provincetown through digitization.

#### Proposal

To utilize the second floor of the Freeman Street building through June 30, 2007, for the purposes of digitizing documents for future use for research and public information, and to establish a History Preservation Project Gift Fund to accept donations to further the goals of the Project. This project will be overseen and supervised by the Town Clerk.

#### Goals

- 1. To move inaccessible documents and photos from where they are currently housed in the attic of the Grace Gouveia building to the second floor of the Freeman Street building where they can be safely assessed, scanned and computerized;
  - 2. To assess historical documents in Town Hall for preservation efforts;
  - **3.** To prioritize documents for digitization; and to develop policies and procedures on the digitization process;
  - **4.** To secure funding to support digitization through available grants, existing funding sources in Town Hall (i.e. Community Preservation Act allocations, Tourism Fund, etc.), and from private gift support from the community;
  - **5.** To develop a training program for project volunteers and procedures to oversee their work; and
  - 6. To digitize as many documents as possible within the existing time frame and place documents on a specifically designed web page to create greater access to valuable and significant historical information.

#### Rationale

Use of the space in the Freeman Street building will provide the safe and secure environment needed to house the materials and allow workspace for scanners, computers, and the clean layout of materials so that project volunteers can efficiently sort and preserve this history.

This proposal, with a project deadline of June 30, 2007, is designed as an interim measure while the Town continues its ongoing discussions with the Pilgrim Monument and Provincetown Museum regarding potential transfer of Town historical information, and also while the Town continues to explore future uses of the Freeman Street building.

The majority of historic documents in the Town's care are currently stored in the attic of the Grace Gouveia building. Historical information currently in the Town Clerk's care and located in Town Hall will also be evaluated for inclusion in this preservation project.

Access to documents in the Grace Gouveia attic is extremely difficult due to the crowded storage conditions that exist. Continued exposure of the documents to the attic environment is detrimental to their integrity and threatens their continued existence.

The successful completion of this project will ensure that important documents related to Provincetown's history will be preserved for informational and research purposes today and for the future, providing access for Town boards and the general public.

#### Cost

It is estimated that \$10,000 will be needed to support this project. Budgetary items include training, preservation materials, computer and scanning equipment, in addition to technical support to create a fully functioning, interactive website.

Funding will be sought from a variety of sources, including available grants, Community Preservation Act allocations, Tourism Fund, existing budgets, and private gift support from the community. To date, individual community gift support in the form of pledges amounts to \$2,250.

Besides funds already committed through Town Budgets, the Heritage Museum Friends Association and private gifts and pledges, additional funds will be sought from Seamen's Long Point Charitable Foundation, the Cape Cod Foundation, the Masonic Lodge, the Kelley Foundation, the Arts Foundation of Cape Cod, Cape Cod Five Cents Savings Bank and the TD BankNorth Charitable Foundation. In addition, a major grant possibility is a National Leadership Grant: Building Digital Resources from the Institute of Museum and Library Services.

Project work will be provided by trained volunteers from the community at no cost, and moving of the material from the Grace Gouveia building and Town Hall will be conducted by participants in the Barnstable County Sheriff's Office of Community Service Project, also at no cost.

Your thoughtful consideration of this proposal is greatly appreciated.

As many of you know, I was heavily involved in the Heritage Museum during its final 10 years of existence, as a volunteer and Board member. My dismay and heartache regarding its closing and the moth-balling of the Museum's prodigious and priceless collection are beyond words.

I am thrilled that Doug Johnstone and a group of like-minded individuals have taken it opon themselves to unearth at least a portion of this collection and make it accessible to the public in an organized fashion.

To the great credit of Josephine Del Deo, volunteer curator of the Museum for 25 years, and Dale Fanning, its more recent Director, the Museum collection has been inventoried, catalogued, and carefully stored to assure its preservation.

The Heritage Museum's photo archive alone contains over 1,200 photos, postcards, slides, and negatives, many of which are unavailable elsewhere. There are hundreds of other documents, records, correspondence, books, pamphlets, programs, newspaper articles, maps, etc., all illuminating a slice of Provincetown's rich and varied history. There are huge collections which were donated to the town by Seamen's Bank, the Provincetown Advocate, and many other businesses, fraternal organizations, arts and cultural organizations, and individuals the likes of Dr. Daniel Hiebert, Norman Cook, Nat Halper, Ross Moffett, Cyril Patrick, and countless others. Dear Fellow Working Group Members - Success! Last night the Board of Selectmen unanimously approved our History Preservation Project proposal, thereby allowing us use of the 2nd (and 3rd) floor of the Freeman Street building until June 30, 2007, and the establishment of a History Preservation Project Special Gift Fund so that we can accept donations specifically for our project.

Now the work begins.

At the moment, everything else is predicated on two things:

- 1. Moving the collection into the Freeman Street building so that the Prioritization Group can begin their work; and
- 2. Determining the equipment we will be using and the specific software so the Work Flow group can fully develop a work flow plan and procedures.

To that end, it will be more difficult for the Locksmith to install new locks due to missing keys for the inner back stairwell doors (all 4 of them), so he anticipates completion by this Friday, September 15th. Given how open the Library is in it's current state (one key opens all doors - and there may be several hundred keys floating around in the community) I am extremely reluctant to move the material until we have changed the locks and secured the 2nd and 3rd floors - so any planned move tentatively scheduled for this Thursday, 9/14, will have to wait until the new locks are on the building.

If the Locksmith completes his work this Friday 9/15, and it is not raining on Saturday, 9/16, and I can get at least two other people to help me move material (I already have one person who can help), then we can plan to move the material into the Freeman Street building on Saturday 9/16. Please note that we would be completing this move without the benefit of the Sheriff's Office inmates, but the boxes are light and if coordinated, should not amount to that much heavy lifting. I would like to get the material moved this weekend so that the Prioritization group can begin their work.

If anyone has any time between now and Saturday, the floors could use a good vacuuming and dusting, I can supply the equipment, if someone has the time (hey, it doesn't hurt to ask).

The Prioritization Group (who will be developing the prioritization list we will use throughout the project) will be lead by Josephine Del Deo, and I would like to suggest she be joined by Polly Burnell, Susan Leonard, and David Mayo, with Dale Fanning in an Advisory capacity via phone as/if needed.

The technical aspects of the project should be determined as soon as possible (within the next week?), at which point the Work Flow group can develop procedures. I would like to suggest that Lyn Kratz (who has volunteered on this task) be joined by Dick Chaoutte and Taylor Polites (Dick has helped the Monument in their work, and Taylor has recently applied to join the Historical Commission and may have helpful insights in this area), with Laurel Guadazno also involved (and Debbie - do you have time for this?).

This week I will be contacting by mail or e-mail those who so generously showed their early support for the project by pledging money to help us meet our goals with information on the Special Gift fund and how they can send in their tax-deductible donation, and overseeing building preparation so that - with luck and good weather - we can move the material this weekend.

If you are interested in any of the above mentioned areas and your name is not mentioned - just let me know (on the flip side, if your name is suggested above but you do not wish to work in that area please let me know). I would like to have the groups organized by the

end of this week so that you can meet separately as groups to begin your work (or at least be in contact with each other to coordinate your schedules). My focus next week will need to be on the State Primary Election so I am relying on your continued hard work and support to get these groups up and functioning.

Since we have to wait for equipment purchase and set-up anyway, we can use this time to develop the road map (Prioritization) and how we will accomplish the work (Work Flow) - so our time will not at all be wasted and we can hit the ground running.

Volunteer recruitment and training will follow, but we have work yet to accomplish before we can put our volunteer workforce to use on the actual project.
