Why are so many members "out of Town"?

October 7, 1884:

"Mr. Logan inquired if Mr. Lowe could absent himself from every meeting without being dropped from the rolls. He was informed that all members of the company connected with lighthouses or the life-saving service, when not present at meetings were considered out of town."

November 2, 1886:

"Resolved: That in case an active member is rendered incapable by sickness or accident from performing his duty while at sea, he shall be entitled to and receive his benefits, provided he send or bring a true statement of his complaint or accident, certified to by one or more of the officers of the vessel to which he may belong."

For want of a horse -

April 25, 1886:

"An alarm at one o'clock to-day called the department to a fire in the grass in the rear of St. Peters Catholic church. Our engine was dragged there, and after standing round a while the company was ordered home.

"No water was played and no damage done. After dragging the engine home with the help of a horse the roll was called and company dismissed."

July 14, 1887:

"An alarm was sounded at about two o'clock this afternoon for a slight fire in the grass near the high school building. The engine was taken from the house, and by the aid of a horse, which we found on the street, was soon taken to the scene of the fire ..."
