CONSTITUTION OF THE ANTI SLAVERY SOCIETY OF PROVINCETOWN

Preamble

Whereas the Most high God hath made of one blood all nations of men to dwell on all the face of the earth and hath commanded them to love their neighbours as themselves and whereas our national existence is based upon this principle recognized in the declaration of Independence, that all men are created equal, and that they are endowed by their creator with certain unalienable rights, among which are life liberty, and the pursuit of hapiness, and whereas after the lapse of sixty years since the faith and honor of the American people were pledged to this avowal before Almighty God and the world, nearly one sixth part of the nation are held in bondage by their fellow citizens,, And Whereas Slavery is contrary to the principles of national Justice, of our republican form of government and of the christian religion, and is destructive to the Government of the [next page] Country, while it endangers the peace, union and liberties of the states, and Whereas we believe it is practicable by appeals to the consciences, hearts and interests of the people to awaken a public sentiment throughout the nation that will be opposed to the continuance of Slavery in every part of the republic, and by affecting the speedy abolition of Slavery prevent a general convulsion, and Whereas we believe we owe it to the oppressed, to our fellow citizens who hold slaves, to our whole country, to posterity, and to God, to do all that is lawfully in our powers to bring about the extinction of slavery, we do hereby agree with a powerfull reliance on the divine aid to form ourselves into a society to be governed by the following Constitution.

Article first. This Society shall be called the Anti Slavery Society in Provincetown

Article Second. The object of this society is to petition Congress to put an end [next page] to the domestic Slave trade, and to abolish Slavery in all those positions of our common country which came under its control, especially in the District of Collumbia [Columbia], and likewise to prevent the extension of it to any state that may be hereafter admitted to the union.

Article third. Any person who consents to the principles of this constitution and subscribes their name to the same may be a member of this society and shall have a right to vote at the meetings.

Article Fourth. The Officers of this society shall be a President, three vice Presidents, Secretary and a board of Managers consisting of seven, they shall be annually chosen by the society and seven of the officers shall constitute a quorum.

Article Fifth. The President shall preside at all meetings of the society, and in his absence one of the vice presidents or in their absence a President Pro Tem. [Next page] The Secretary shall record all votes passed and all the proceedings of the society and also notify all meetings of the society. The board of Managers shall take charge of all Petitions and obtain subscribers.

Article Sixth. The annual Meeting of the society shall be held on the second Monday evening in the Month of December in each year.

Article Seventh. This constitution may be altered or amended at any meeting of the society by a vote of two thirds of the members present, provided the amendments have been previously submitted to the board of Managers in writing.

Voted to have the constitution read and agreeable to said vote the constitution was read by the Secretary.

Voted to remonstrate to Congress against the anexation of Texas to the union.

Voted to Petition Congress to regulate commerce so as to stop the traffick in human beings.

Voted to Petition the General Consul on Slavery.

Voted to petition Congress to abolish Slavery in the District of Collumbia.

Voted that a Petition be circulated today to the town for subscribers against the annexation of Texas to the union.

Voted to request the Lodgers [?] of this town to petition Congress for the abolition of Slavery in the District of Columbia.

Voted that the board of Managers circulate the petitions for signers as soon as may be and return them to the [next page] Secretary who shall forward them to those they are invested [?].

Voted that the Society meet on the first Thursday evening in each month untill otherwise altered by the society.

Voted to adjourn.

Nov 14 - 1838 Society met at six o'clock - meeting opened with prayer by Rev. I. M. Bidwell. The president stated the object of the Meeting to be the importance of petitioning Congress.

Voted that the records of the society be read, and agreeable to said vote the Sec. [Secretary] read the same.

Voted that petitions be circulated through the town for signers.

Voted that Messrs. Soloman Rich, Esq., John Dyer and Robert Knowles be a committee to circulate the petitions.

Voted that the Secretary be instructed to recommend to the Female Anti Slave Society the subject of petitioning Congress.

Voted their be a committee of three to collect funds to purchase forthwith Anti Slavery books for the use of the Society + proprietors.
