Dear Mr. Russell:

Thank you for your recent letter in opposition to proposed reductions in federal support for the National Endowments for the Arts and for the Humanities.

I share your strong support for the financial integrity of the Endowments and can certainly understand your frustration with the President's proposal to cut their fiscal year 1982 budgets in half. I realize the importance of the Endowments' assistance programs, not only to Provincetown, but to productive artistic institutions and endeavors across the country. Accordingly, while it is clear that the 97th Congress will approve some substantial reductions in the federal budget, I can assure you that I will oppose efforts to slash the Endowments' budget disproportionately.

Although President Reagan has proposed these budget cuts, I would like to emphasize to you that it will be up to the Congress to determine whether or not to approve them. It is impossible to predict precisely what action the House and Senate will take regarding arts funding programs. It is my intention, however, to do whatever I can to see that the commitment of the federal government toward providing artistic opportunities to deserving enterprises does not suffer. As a member of the Congressional Arts Caucus, I will continue to urge my colleagues in the House of Representatives to scrutinize the potential impact of the President's proposals for the Endowments.

Again, I appreciate your taking the time to write. Please let me know if I can provide any additional information or assistance.

Several people suggested that we contact you about our project of starting a summer theatre in Wellfleet. This is a copy of the proposal which we have sent to the Roman Catholic Church, Congregational Church, and the Masonic Lodge, all located in Wellfleet.

We are a newly formed theatre company trying to establish ourselves in Wellfleet. We have named the theatre the Outer Cape Performance Company. We recently became a non-profit corporation and are currently in the process of applying for tax-exempt status. Our ultimate goal (and our reason for existing) is two-fold. First, we wish to establish a professional summer theatre on the Lower Cape that will offer different fare from that of other Lower Cape theatres. Secondly, the Lower Cape contains the necessary resources in terms of artists, designers, playwrights, directors, and actors to supply any summer season with a wealth of talent. We wish to delve fully into this resource and eventually utilize it entirely.

We are planning to do three productions of eight performances each, on a Wednesday through Saturday schedule; and would need the space for each evening of performance from approximately, 6:30 - 11:00 P.M. . We would also need the space three days prior to each opening for a few hours each day, to load in sets and set pieces, set light cues, and acclimate the actors to the stage. This of course would not include any Sunday. We have set up a schedule which is as follows:

1st production July 15th-18th and July 22nd-25th.

2nd production July 29th-Aug. 1st and Aug. 5th-8th.

3rd production Aug. 26th-29th and Sept. 2nd-5th.

What we need is:

- 1. Rental of the basement space with the stage.
- 2. Seating for patrons.
- 3. Use of electricial outlets for lighting and audio equipment.
- 4. Use of restrooms and parking facilities.
- 5. A place to store set pieces and props and valuables.

A partial list of plays that we are considering for our 1981 season are: LATER by Corrine Jacker, EXIT THE KING by Eugene Ionesco, THE HOMECOMING and THE CARETAKER by Harold Pinter, U.S.A. by John Dos Passos, THE SEAHORSE by Edward Moore, HOME by David Storey, THE GREAT LOVER by Andre Dumas (pere), THE WOODS by David Mamet, TALLEY'S FOLLY by Lanford Wilson. If you are curious about the content of any to these selections, please get in touch with us and we will be happy to summarize them for you. We are also soliciting new scripts from Cape residents hoping to put at least one orginal script onstage in our first season.

We are both graduates of the Neighborhood Playhouse School of the Theatre in New York City. We both have worked for Joseph Papp's New York Shakespheare Festival in the carpentry, property, and audio departments. Michael was also Master Electrician on the Off-Broadway production of Gemini, which later moved to Broadway. Deborah was assitant on a number of productions to Jack Hofsiss. who directed the Tony Award-Winning ELEPHANT MAN. Our acting experience covers numerous productions of classics as well as several orginal works by new playwrights. We have produced many plays and have experience as production coordinators with the Performers Ensemble Theatre during their residence at St. George's Chapel in New York. Deborah went to Villanova University and majored in Theatre Arts. Michael to Hampshire and Columbia Colleges majoring in Theatre History. Michael grew up in Truro and has been returning every summer since his parents moved to Bethesda, Maryland. Deborah has been coming up every summer since 1975.
