67 Commercial St. is a 3-story; 3-bay sidehall dwelling; the roof is clad in asphalt shingles with partial cornice returns; the exterior is clad in vinyl siding; fenestration includes 1/1 DHS aluminum windows with inoperable shutters; single-light casements; the primary entrance has stoop with wrought iron railings, pane and panel wood door and aluminum storm; multiple decks on rear façade.
