100 Commercial Street is a 2-1/2-story, 3-bay Colonial Revival-style dwelling; the gable-front roof is sheathed in asphalt shingles; the exterior is clad in vinyl siding, building sits on a brick foundation; fenestration includes 2/2 vinyl DHS, 2/2 wood DHS, 6/6 wood in gable end, vinyl-wrapped surrounds and inoperable shutters; primary entrance is accessed by a wood pane-and-panel door and an aluminum storm door, and has inoperable shutters; rear 1-story addition with asphalt shingles, concrete block chimney, 2/2 vinyl DHS and paired 4-pane wood casements.
