290A Commercial St. is a 2-1/2-story, 3-bay Colonial Revival-style mixed use residential/commercial building; gable-front roof is sheathed in asphalt shingles, pilastered and arched chimney, skylight; exterior is clad in wood shingles with wood corner boards and trim; building sits on a brick foundation; fenestration includes 2/1 replacement DHS, louvered inoperable shutters; modern business entrance at basement level flanked by paired 1/1 DHS; 1-story rear addition..
