476A Commercial St. is a 1-story, 3-bay, Bungalow-style dwelling; gable-front roof is sheathed in asphalt shingles, interior brick chimney at roof ridge; exterior is clad in wood shingles with wood trim; building sits on a parged foundation; fenestration includes 4/1 DHS wood windows; central enclosed shed-roof porch is flanked by 4/1 DHS triple windows; windows in the enclosed porch are casements; other details are obscured from view.
