Obscured from view; 164 Bradford Street is a 1-story, 4-bay, Astylistic 3/4 cottage; the roof is side gable and a central chimney is located below the ridge on the rear roof slope; the exterior is clad in wood shingles; the fenestration includes 1/1 DHS windows with wood trim; the primary entrance contains a door with wood trim; an entry vestibule as been added to the rear of the side façade of the building.
