647 Commercial St. is a 2-story, 3-bay dwelling; side gambrel roof is sheathed in wood shingles; partial cornice returns; shallow 3-bay shed dormer on front roof slope; interior brick chimney at ridge; exterior is clad in wood shingles with wood corner boards and trim; fenestration includes 2/2 DHS windows; most have wood shutters; entrance in center bay with storm door; 1-story hipped-roof porch supported by square posts; raised porch wraps around to south side; roof over rear porch not visible.
